Sealed bids addressed to the MATAGORDA COUNTY NAVIGATION DISTRICT NO. 1 of Palacios, Texas, will be received at the Matagorda County Navigation District No. 1/Port Administration Building, 1602 Main Street, Palacios, Texas 77465, until **2:00 p.m., THURSDAY, DECEMBER 9, 2021**, for the Turning Basin No. 4 Drainage Improvements FEMA Alternate Project DR-4332-TX (PA ID No. 321-UPU2Q-00) in Palacios, Matagorda County, Texas.

Immediately following the closing time for receipt of Bids, the Bids will be publicly opened and read aloud at the Matagorda County Navigation District No. 1/Port Administration Building, 1602 Main Street, Palacios, Texas 77465. Any Bids received after closing time will be returned unopened.

A pre-bid conference will be held at the Matagorda County Navigation District No. 1/Port Administration Building, 1602 Main Street, Palacios, Texas 77465 at **2:00 p.m., THURSDAY, DECEMBER 2, 2021**. All Bidders are strongly urged to attend.

The project consists of the injection of structural polyurethane grout and associated pavement repairs to achieve positive drainage along approximately 950 linear feet of concrete pavement in Turning Basin No. 4 at the Port of Palacios in Matagorda County, Texas.

Bidders must submit a bid bond, cashier's or certified check payable without recourse to the order of the MATAGORDA COUNTY NAVIGATION DISTRICT NO. 1, in an amount not less than five percent (5%) of the bid submitted as a guarantee that the Bidder will enter into a contract and execute bonds and guarantee in the forms provided within fifteen (15) days after Notice of Award of contract to him. Bids submitted without the required security will not be considered.

The successful Bidder will be required to purchase and furnish a Performance Bond and a Payment Bond, each in the amount of the contract, written by a responsible surety company, authorized to do business in the State of Texas, as required by Article 5160, V.A.T.C.S., as amended by H.B. 344, passed by the 56th Legislature, Regular Session, 1959.

Bidders are expected to inspect the site of the work and to inform themselves regarding all local conditions.

Information for Bidders, proposal forms, specifications and plans are available for inspection during regular business hours at Urban Engineering, 2004 N. Commerce, Victoria, Texas 77901, (361) 578-9836.

Prospective Bidders may obtain complete copies of the plans, project manual and specifications from Urban Engineering. An electronic file copy is available at no charge or a printed copy is available for a non-refundable fee of \$100.00 per copy. Bidders are required to obtain a complete copy of the Bidding Documents from Urban Engineering to submit a bid.

This project is being funded in part by a FEMA Public Assistance Grant. All contractors/subcontractors that are debarred, suspended or otherwise excluded from or ineligible for participation on federal programs may not undertake any activity in part or in full under this project.

Small and minority businesses, women owned business enterprises, and labor surplus area firms are encouraged to submit bids and Bidders using subcontractors must solicit such firms in the subcontracting process.
