## II. PLANNING WORKSHOP

- 1. Matagorda County Economic Development Corporation Mr. Martinez opened the discussion on the MCEDC topic with some quick background information and introduced Judge Nate McDonald and Mitch Thames who currently both serve as MCEDC Officers. Mitch Thames gave more background and discussion on the MCEDC mission, history, and information. Judge McDonald also gave his history with MCEDC and working to bring development to Matagorda County over the last 14 years. The Commissioners had some questions for each of these attendees but also discussed in detail their concerns not only from them, but also from their constituents. After much discussion Mr. Martinez closed the topic as to keep the meeting on scheduled.
- 2. Texas Department of Transportation Rider 38 Port Access Program Mr. Martinez gave an update on this project. Asked the Commissioners to consider moving forward with the project by approving an action at the next Regular Board Meeting which will allow Mr. Martinez to draft a Resolution that must be done and submitted to TxDOT as soon as possible. Mr. Martinez stated the action to move forward will help with ensuring the Commissioners want to continue with this project and the Port Access Program.
- 3. Rates and Tariffs Mr. Martinez opened this discussion by giving some background information on the Rate and Tariffs of the District. The Commissioners discussed this in detail recognizing that these items need to be raised or adjusted to meet at least the standard yearly inflation rates. Mr. Martinez asked the Commissioners to consider putting this topic on one of the next few Agendas and before we begin Budget Season.
