A tax rate of \$0.00935 per \$100 valuation has been proposed by the governing body of Matagorda County Navigation District #1.

The no-new-revenue tax rate is the tax rate for the 2023 tax year that will raise the same amount of property tax revenue for Matagorda County Navigation District #1 from the same properties in both the 2022 tax year and the 2023 tax year.

The voter-approval rate is the highest tax rate that Matagorda County Navigation District #1 may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that Matagorda County Navigation District #1 is proposing to increase property taxes for the 2023 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON September 27, 2023 AT 1:00 PM AT MCND #1 Administration Building, 1602 Main Street, Palacios, TX 77456.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, Matagorda County Navigation District #1 is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the of Matagorda County Navigation District #1 at their offices or by attending the public hearing mentioned above.
